AGREED MOTION TO ABATE

COME NOW Applicants Pendleton Water Supply Corporation ("Pendleton WSC") and the City of Troy, Texas ("Troy") and the Public Utility Commission of Texas ("Commission") Staff ("Staff") (collectively, the "Parties"), and file this Agreed Motion to Abate. In support, the Parties respectfully show the following.

On March 8, 2022, Pendleton WSC and Troy filed an application for approval of a service area contract and to amend Pendleton WSC's water Certificate of Convenience and Necessity ("CCN") No. 10003 and Troy's water CCN No. 10004 in Bell County, Texas. On June 8, 2022, Commission Staff filed its Final Recommendation recommending approval of the application. Under Order No. 3 Amending Procedural Schedule, issued on May 10, 2022, the only deadline remaining in this proceeding is for the Parties to file joint proposed findings of fact and conclusions of law by June 17, 2022.

Pendleton WSC has federal debt issued by the United States Department of Agriculture ("USDA"). Before the application can be approved, and Pendleton WSC's CCN amended, the USDA needs to approve Pendleton WSC's Application for Partial Release, Subordination, or Consent. Pendleton WSC hereby requests abatement of this proceeding for 30 days to allow time for the USDA's approval. Pendleton WSC offers to file a status report on July 11, 2022, at the expiration of the requested 30-day abatement to inform the administrative law judge ("ALJ") if

the USDA issued its approval, or if additional time is needed. Pendleton WSC respectfully requests the presiding ALJ issue an order granting and consistent with this motion.
