<u>The requested area overlaps the district boundaries of Brazos River Authority</u>. If this district does not request a public hearing, the Commission shall determine that the district is consenting to CSWR-Texas Utility Operating Company, LLC's request to provide retail sewer utility service in the requested area.

The sale is scheduled to take place if approved by the Commission (Texas Water Code § 13.301). The transaction and the transfer of the CCN includes the following subdivision: Shady Grove Subdivision.

The requested area includes <u>10</u> customer connections, is located approximately <u>2.8</u> mile(s) <u>east</u> of downtown <u>Granbury</u>, Texas, and is generally bounded on the north by <u>Betty Court</u>; on the east by <u>Cleveland Road</u>; on the south by <u>Acton Highway</u>; and on the west by <u>Davis Road</u>.

The requested area includes approximately <u>17</u> acres of transferred area from CCN No. 20767 to CCN No. 21120.

The application proposes the subtraction of approximately <u>17</u> acres from CCN No. 20767 and the addition of approximately <u>17</u> acres to CCN No. 21120.



Box 13326, Austin, Texas 78711-3326, or call the Public Utility Commission at (512) 936-7120 or (888) 782-8477. Hearing- and speech-impaired individuals with text telephones (TTY) may contact the commission at (512) 936-7136. The deadline for intervention in the proceeding is (30 days from the mailing or publication of notice, whichever occurs later, unless otherwise provided by the presiding officer). You must send a letter requesting intervention to the commission which is received by that date. The letter must include the person's name, address, email address and fax number if applicable.

If a valid public hearing is requested, the Commission will forward the application to the State Office of Administrative Hearings (SOAH) for a hearing. If no settlement is reached and an evidentiary hearing is held, SOAH will submit a recommendation to the Commission for final decision. An evidentiary hearing is a legal proceeding similar to a civil trial in state district court.


