Based on our conversation, it sounds like the permit will transfer upon the sale of the system. My understanding is that to maintain the permit, CSWR will need to reach out to your office and provide a copy of a maintenance contract that is satisfactory to Hood County. The contract should ensure, at a minimum, contact information in the event of an emergency and that the facility be inspected three times a year. It is your office's preference that the contract be with an entity that is local. That would facilitate a quick response in the event of an emergency.
