Pursuant to Texas Water Code § 13.257(r) and (s), CSWR-Texas Utility Operating Company, LLC (CSWR-Texas), holder of sewer Certificate of Convenience and Necessity (CCN) No. 21120, hereby files this Boundary Description for the CSWR-Texas sewer system, which is located in Hood County, Texas.

In accordance with the aforementioned statute, CSWR-Texas affirmatively states that its sewer service area included in the aforementioned CCN is as follows:

The requested sewer area is located approximately 2.8 miles east of downtown Granbury, Texas and is generally bounded on the north by Betty Court; on the east by Cleveland Road; on the south by Acton Highway; and on the west by Davis Road.

The requested area comprises approximately 17 acres and 10 customer connections.

The service area is further depicted in the attached PUC certified map.

The Boundary Description is being filed on behalf of and at the request and instruction of CSWR-Texas based upon information and belief. CSWR-Texas specifically authorizes the filing of this Boundary Description to comply with Texas Water Code § 13.257(r) and (s) and its associated rules and regulations.




