COMMISSION STAFF’S REQUEST FOR EXTENSION

On March 10, 2022, Denton Oliver Creek, LP (Denton Oliver Creek) filed a petition for streamlined expedited release from the City of Justin's (City of Justin) sewer Certificate of Convenience and Necessity (CCN) No. 20061 under Texas Water Code (TWC) § 13.2541 and 16 Texas Administrative Code (TAC) § 24.245(h). Denton Oliver Creek asserts that the land is at least 25 contiguous acres, is not receiving sewer service, and is located in Denton County, which is a qualifying county.

On June 9, 2022, the administrative law judge (ALJ) filed Order No. 3, establishing a deadline of July 20, 2022 for the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a recommendation on final disposition. Therefore, this pleading is timely filed.

I. REQUEST FOR EXTENSION

Under 16 TAC § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff requires additional time to complete the final recommendation in this docket. As such, Staff respectfully requests that the deadline for Staff to file its recommendation on final disposition be extended to July 25, 2022. Staff has conferred with counsel for Denton Oliver Creek and is authorized to state that Denton Oliver Creek is unopposed to this request.

II. CONCLUSION

For the reasons detailed above, Staff respectfully requests the entry of an order extending Staff’s deadline to July 25, 2022.
