**COMMISSION STAFF'S REQUEST FOR EXTENSION**

On March 10, 2022, Cross Timbers Water Supply Corporation (Cross Timbers WSC) and the Stonebridge Water Supply Corporation (Stonebridge WSC) (collectively, Applicants) filed an application for sale, transfer, or merger (STM) of facilities and certificate rights in Denton County, Texas, under Texas Water Code (TWC) § 13.301 and 16 Texas Administrative Code (TAC) § 24.239

On December 2, 2022, the administrative law judge (ALJ) filed Order No. 8, finding the closing documentation sufficient and directing the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a joint proposed notice of approval, including findings of fact, conclusions of law, and ordering paragraphs, by January 12, 2023. Therefore, this pleading is timely filed.

**I. REQUEST FOR EXTENSION**

Under 16 Texas Administrative Code (TAC) § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff needs additional time to confer with the Applicants on issues pertaining to the application before submitting its joint notice of approval. As such, Staff respectfully requests that the deadline to file the joint notice of approval be extended until January 19, 2023.

**II. CONCLUSION**

For the reasons discussed above, Staff respectfully requests the issuance of an order consistent with the above-mentioned recommendation.
