COMMISSION STAFF'S PROPOSED PROCEDURAL SCHEDULE

On March 11, 2022, Big Easy Agua LLC (Big Easy) filed an application to obtain a water Certificate of Convenience and Necessity (CCN) in Colorado County. The requested service area consists of 1,039 acres and 0 connections.

On July 21, 2022, the administrative law judge filed Order No. 4 requiring the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a proposed procedural schedule for continued processing by July 21, 2022. Therefore, this pleading is timely filed.

I. PROCEDURAL SCHEDULE

Staff proposes the following procedural schedule:

Event	Date
Notice complete	April 27, 2022
Deadline to intervene	May 27, 2022 ¹
Deadline for Staff to request a hearing or file a recommendation on the approval of the sale	August 18, 2022
Deadline for parties to file a response to Staff's recommendation on approval of the sale	August 25, 2022
Deadline for parties to file a joint motion to admit evidence and proposed order approving the sale and allowing the transaction to proceed	September 8, 2022

¹ Under 16 Texas Administrative Code § 24.239(b), the intervention period is 30 days from the mailing or publication of notice, whichever occurs later. Notice was last published on April 27, 2022. Therefore, 30 days after April 27, 2022, is Friday, May 27, 2022.

II. CONCLUSION

For the reasons detailed above, Staff recommends that the proposed procedural schedule be adopted and respectfully requests the entry of an order consistent with this recommendation.
