COMMISSION STAFF'S PROPOSED PROCEDURAL SCHEDULE

On March 11, 2022, Big Easy Agua LLC (Big Easy) filed an application to obtain a water Certificate of Convenience and Necessity (CCN) in Colorado County. The requested service area consists of 1,039 acres and 0 connections.

On August 5, 2022, the administrative law judge filed Order No. 5 requiring the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a proposed procedural schedule for continued processing by August 12, 2022. Therefore, this pleading is timely filed.

I. PROCEDURAL SCHEDULE

Staff proposes the following procedural schedule:

Event	Date
Notice complete	April 27, 2022
Deadline for intervention	May 27, 2022 ¹
Deadline for Staff to provide final maps, certificates, and tariffs (if applicable), to Applicant for review and consent	August 18, 2022
Deadline for Applicant to file signed consent forms with the Commission	September 1, 2022
If no hearing is requested, deadline for Staff to file a final recommendation on the Application	September 8, 2022
If no hearing is requested, deadline for parties to file joint proposed findings of fact and conclusions of law	September 22, 2022

¹ Under 16 Texas Administrative Code § 24.239(b), the intervention period is 30 days from the mailing or publication of notice, whichever occurs later. Notice was last published on April 27, 2022. Therefore, 30 days after April 27, 2022, is Friday, May 27, 2022.

II. CONCLUSION

For the reasons detailed above, Staff recommends that the proposed procedural schedule be adopted and respectfully requests the entry of an order consistent with this recommendation.
