COMMISSION STAFF'S REQUEST FOR EXTENSION

I. INTRODUCTION

On March 11, 2022, Big Easy Agua LLC (Big Easy) filed an application to obtain a water Certificate of Convenience and Necessity (CCN) in Colorado County. The requested service area consists of 1,039 acres and 0 connections.

On July 12, 2023, the administrative law judge filed Order No. 21, requiring the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a recommendation on the supplemental information provided by Big Easy by August 7, 2023. Therefore, this pleading is timely filed.

II. REQUEST FOR EXTENSION

Under 16 Texas Administrative Code § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Big Easy filed corrected mapping last week on July 26, 2023, which does not give Staff sufficient time to make its recommendation by August 7, 2023. Accordingly, Staff respectfully requests that Staff's deadline to file its recommendation be extended to September 6, 2023. Staff has conferred with Big Easy's representative and is authorized to represent that it is unopposed to the extension request.

III. CONCLUSION

For the reasons detailed above, Staff respectfully requests that its deadline to file a recommendation on the supplemental information provided by Big Easy be extended to September 6, 2023.
