**COMMISSION STAFF'S REQUEST FOR EXTENSION**

**I. INTRODUCTION**

On March 11, 2022, Big Easy Agua LLC (Big Easy) filed an application to obtain a water Certificate of Convenience and Necessity (CCN) in Colorado County.

On October 20, 2023, the administrative law judge filed Order No. 26, instructing the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a recommendation on the supplemental information provided by Big Easy and to move to admit its recommendation by November 7, 2023.

**II. REQUEST FOR AN EXTENSION**

Under 16 TAC § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Big Easy completed its responses to Staff's requests for information on Wednesday, November 1, 2023.<sup>1</sup> Staff requires slightly more time to complete its review and response to Order No. 19. Accordingly, Staff respectfully requests the entry of an order extending the deadline to file a recommendation on the supplemental information provided by Big Easy and move to admit its recommendation be extended to November 10, 2023.

**III. CONCLUSION**

For the reasons detailed above, Staff respectfully requests that its deadline to file a recommendation on the supplemental information provided by Big Easy be extended to November 10, 2023.
