#### JOINT SUPPLEMENTAL MOTION TO ADMIT EVIDENCE

#### I. INTRODUCTION

On March 11, 2022, Big Easy Agua LLC (Big Easy) filed an application to obtain a water Certificate of Convenience and Necessity (CCN) in Colorado County. The requested service area consists of 1,039 acres and 0 connections.

On November 13, 2023, the administrative law judge filed Order No. 28, instructing parties must file a motion to admit the evidence or an explanation as to why the information does not need admitted into evidence by November 29, 2023. Therefore, this pleading is timely filed.

#### II. MOTION TO ADMIT RECOMMENDATION

Parties hereby request that the following items be admitted into the record of this proceeding:

- 5. Big Easy's response to Commission Staff's second request for information, confidentially filed on October 19, 2023;
- Big Easy's response to Commission Staff's third request for information, filed on November 1, 2023; and
- Big Easy's additional response to Commission Staff's second request for information, filed confidentially on October 19, 2023.

Parties do not recommend including Commission Staff's second request for information,

filed on September 6, 2023, nor Commission Staff's third request for information, filed on

November 1, 2023, because those filings are included in Big Easy's responses to each request for information and including them would be duplicative.

### III. CONCLUSION

The parties respectfully request that the items listed above be admitted into the record of this proceeding.
