**COMMISSION STAFF'S REQUEST FOR EXTENSION**

On March 11, 2022, W&W Water, Inc. (Applicant) filed an application for a Class D rate adjustment for the water systems under its water Certificate of Convenience and Necessity (CCN) No. 12023.

On March 15, 2022, the administrative law judge (ALJ) filed Order No. 1, establishing a deadline of April 11, 2022, for the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a recommendation on the administrative completeness of the application and notice, and a recommendation on final disposition if Staff recommends that the application be deemed administratively complete. Therefore, this pleading is timely filed.

**II. REQUEST FOR EXTENSION**

Under 16 TAC § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. On March 21, 2022, Staff filed a ten-day letter requesting additional information from the Applicant. To date, the Applicant has not provided such additional information, and Staff requires the additional information to complete its recommendation. Therefore, Staff respectfully requests that the Applicant be ordered to file the additional information referenced in the ten-day letter by April 25, 2022. Staff further requests that its deadline to file a recommendation on administrative completeness be extended to May 6, 2022, as Staff will need sufficient time to assess any additional information that is filed in the docket.

**III. CONCLUSION**

Staff respectfully requests the entry of an order consistent with the foregoing requests.
