**SUPPLEMENT TO ELECTRIC RELIABILITY COUNCIL OF TEXAS, INC.’S REPLY  
RELATED TO HIGHLY SENSITIVE PROTECTED MATERIALS**

Electric Reliability Council of Texas, Inc. (“ERCOT”) files this Supplement to its Reply to Complainant Engie Energy Marketing NA, Inc.’s (“Engie”) Response to ERCOT’s Notice and Motion Regarding ERCOT’s Challenge to Designation of Highly Sensitive Protected Materials (the “Response”).

ERCOT filed its Reply yesterday and stated that the parties were diligently working toward a resolution of the issues raised in ERCOT’s Motion and Engie’s Response.

ERCOT and Engie have reached an agreement as to the HSPM settlement agreement and request that the ALJs defer ruling on ERCOT’s Motion unless and until ERCOT re-urges the Motion, which the parties have agreed will not occur until after Engie files its objections to ERCOT’s Direct Testimony.
