## AFFIDAVIT OF KEVIN BOGARD

BEFORE ME, the undersigned authority, on this day personally appeared Kevin Bogard, President of South Houston Green Power, LLC who swore an oath that the following facts are true:

- 1. My name is Kevin Bogard. I am the President of South Houston Green Power, LLC ("SHGP") and the highest-ranking officer with binding authority over SHGP. I am over 18 years of age, of sound mind, competent, and authorized to make this affidavit on behalf of SHGP. I have personal knowledge of the matters described herein.
- SHGP is registered with the Public Utility Commission of Texas as a power generation company and owns the assets located on the premises having an address of 2501 5th Avenue, Texas City, Texas 77590. In my capacity as President, I have binding authority over the operational assets of SHGP.
- 3. SHGP filed an emergency operations plan (the "EOP") in accordance with 16 Texas Administrative Code ("TAC") § 25.53 on April 18, 2022.
- 4. No changes have been made to SHGP's list of emergency contacts as provided under 16 TAC § 25.53(c)(4)(B) since SHGP's filing on April 18, 2022.
- 5. No changes have been made to the EOP that materially affect how SHGP would respond to an emergency since SHGP's filing on April 18, 2022.
- 6. The relevant personnel of SHGP and its affiliate, Blanchard Refining Company LLC, are familiar with and have received training on the applicable content and execution of the EOP and such personnel are instructed to follow the applicable portions of the EOP except to the extent deviations are appropriate as a result of specific circumstances during the course of an emergency.
- 7. The EOP has been reviewed and approved by the appropriate executives.
- 8. A drill has been conducted in accordance with 16 TAC § 25.53(f).
- 9. The EOP or an appropriate summary bas been distributed to local jurisdictions as needed.
- 10. SHGP in affiliation with its affiliate Blanchard Refining Company LLC maintains a business continuity plan and that business continuity plan generally addresses returning to normal operations at SHGP after disruptions that may have been caused by an incident or an emergency.

11. In conjunction with SHGP's oversight and management by its affiliate Blanchard Refining Company LLC, SHGP's emergency management personnel who are designated to interact with local, state, and federal emergency management officials during emergency events have received IS-100, IS-200, IS-700, and IS-800 National Incident Management System training and are currently working to complete the latest versions of those trainings where they have been updated commensurate with the level of training required by such emergency management personnel and their authority to interact with local, state, and federal emergency management officials.
