COMES NOW NRG South Texas LP (NRG SO TX), PGC Certificate No. 20147, by and through its operating company, South Texas Project Nuclear Operating Company (STPNOC), and submits this 2023 Annual Review Statement in compliance with 16 Tex. 

## AFFIDAVIT AND ATTESTATION OF MATTHEW PISTNER

BEFORE ME, the undersigned authority, on this day personally appeared Matthew Pistner who, being duly sworn deposed and stated as follows:

- 1. My name is Matthew Pistner. My business address is 910 Louisiana Street, Houston, Texas, 77002. I am over eighteen (18) years of age. I have personal knowledge of the facts contained herein, and to the best of my knowledge, they are true and correct.
- I am currently employed as a Senior Vice President, Generation with NRG Energy, Inc. (NRG). NRG South Texas LP<sup>1</sup> ("NRG SO TX"), being PGC Certificate No. 20147, is a Power Generation Company (PGC) and a subsidiary of NRG. I am authorized to make this affidavit on behalf of NRG SO TX as its President.
- 3. NRG South Texas LP, by and through its operating company, South Texas Project Nuclear Operating Company (STPNOC), filed the Executive Summary and redacted Electric Service Emergency Operations Plan (ESEOP) on April 14, 2022, in Project No. 53385, Item 56. On the same day, it submitted the required nonredacted ESEOP to the Electric Reliability Council of Texas.
- 4. I hereby attest that no changes were made to the ESEOP that materially affect how NRG SO TX would respond to an emergency.
- 5. On behalf of NRG SO TX, I affirm the following:
  - i. All relevant operating personnel responsible for the critical operation of South Texas Project Electric Generating Station are familiar with, and have received training, on the applicable contents and execution of the ESEOP and plant specific documents, and are committed to following the plans and the provisions contained therein in the event of a system-wide or local emergency that arises from natural or manmade disasters, except to the extent deviations are appropriate as a result of specific circumstances in the course of an emergency.
  - ii. The ESEOP has been reviewed and approved by the appropriate executives.

<sup>&</sup>lt;sup>1</sup> NRG South Texas LP is 44% owner and is the Master Qualifying Scheduling Entity (QSE) for the South Texas Project Energy Generation Station (STPEGS) with the other two owners being CPS Energy (40%) and the City of Austin d/b/a Austin Energy (16%).

- iii. NRG SO TX will comply with the requirements for drills contained within the Commission's Emergency Operations Plan rule, subsection (f). In 2022, drills were conducted, and NRG SO TX activated emergency procedures for a hurricane. For 2023, drills are currently planned. NRG SO TX will comply with the requirement for PGCs to provide notification 30 days prior to a drill.
- iv. The ESEOP or a summary will be distributed to local jurisdictions if deemed necessary.
- v. NRG maintains business continuity plans that cover our corporate functions and retail operations. These documents outline our plans to return to normal operations after a disruption caused by an incident.
- vi. All relevant emergency management personnel who are designated to interact with emergency management officials during emergency events have completed the latest IS-100, IS-200, IS-700, and IS-800 National Incident Management System Training.
