II. NOTICE OF CHANGES TO EMERGENCY CONTACTS



BEFORE ME, the undersigned authority, on this day personally appeared the undersigned who, after being duly sworn, stated on his oath that he is entitled to make this Affidavit, and that the statements contained below are true and correct.

“My name is Pat Wood, III. I am the Chief Executive Officer of Hunt Energy Land Company, L.L.C. (“HEN Land Co.”). My business address is 1900 N. Akard St., Dallas, TX 75201. I am the highest-ranking officer with binding authority over HEN Land Co. I swear or affirm that I have personal knowledge of the facts set forth in this Affidavit. I am over 18 years of age and competent to make this affidavit.


HEN Land Co. has an Emergency Operation Plan (“EOP”), prepared in accordance with Public Utility Commission of Texas Subst. Rule §25.53(c) (“Substantive Rule”). I attest and affirm that each of the following are true and accurate:

1. HEN Land Co. personnel have reviewed the current Emergency Operations Plan and determined that the plan continues to support current operations. All changes to the plan did not materially alter how HEN Land Co. would respond to any future emergencies.
2. All relevant operating personnel are familiar with and have received annual training on the contents and execution of the EOP, and such personnel are instructed to follow the EOP except to the extent deviations are appropriate under the circumstances, during the course of an emergency.
3. The EOP has been reviewed and approved by the appropriate executives.
4. HEN Land Co. determined it was unnecessary to distribute the EOP to local jurisdictions at this time.
5. Hurricane drills required under the Substantive Rule were most recently completed on June 21, 2022 and will be conducted again on May 2, 2023, unless the EOP has been activated in

response to an emergency prior to the test.

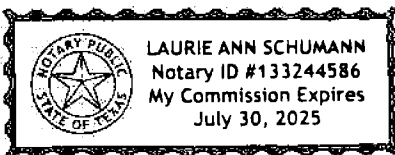
6. HEN Land Co. maintains a business continuity plan that addresses returning to normal operations after disruptions caused by an incident.
7. The emergency management personnel who are designated by HEN Land Co. to interact with local, state, and federal emergency management officials during emergency events have received National Incident Management System training, specifically IS-100, IS-200, IS-700, and IS-800


