Pursuant to 16 Texas Administrative Code ("TAC") § 25.53(c)(3)(B), Chapman Ranch Wind I LLC ("CRW") and Keechi Wind LLC ("Keechi") hereby provide the annual Emergency Operations Plan filing.

CRW and Keechi have not made changes to the Emergency Contacts included in the CRW and Keechi 2022 Emergency Operations Plan Executive Summary document, which was filed with the Commission pursuant to § 25.53 Electric Service Emergency Operations Plans in Project No. 53385 on April 18, 2022. Additionally, CRW and Keechi have reviewed their Emergency Operations Plans and have not made any changes that materially affect how CRW and Keechi would respond to an emergency, as attested to in the affidavit attached as Exhibit A.


## **AFFIDAVIT**

# THE STATE OF TEXAS **COUNTY OF HARRIS**

BEFORE ME, the undersigned authority, on this day personally appeared Robert Jozwiak who swore an oath that the following facts are true:

- 1. My name is Robert Jozwiak. I am the President of and highest-ranking representative, official, or officer with binding authority over Chapman Ranch Wind I LLC ("CRW") and Keechi Wind LLC ("Keechi"). I am over 18 years of age, of sound mind, and competent and authorized to make this affidavit on behalf of CRW and Keechi. I have personal knowledge of the matters described herein.
- 2. CRW and Keechi are registered with the Public Utility Commission of Texas as a power generation companies. CRW and Keechi are both wholly owned subsidiaries of Enbridge, Inc.
- 3. CRW and Keechi filed emergency operations plan (the "Plans") in accordance with 16 Texas Administrative Code ("TAC") § 25.53 on April 18, 2022.
- 4. No changes were made to the Plans that materially affect how CRW and Keechi would respond to an emergency since their filing on April 18, 2022.
- 5. All relevant operating personnel for both CRW and Keechi are familiar with and have received training on the applicable contents and execution of their Plans, and such personnel are instructed to follow the applicable portions of the Plans except to the extent deviations are appropriate as a result of specific circumstances during the course of an emergency.
- 6. CRW and Keechi's Plans have been reviewed and approved by the appropriate executives.
- 7. CRW conducted a drill in November 2022 and Keechi conducted a drill in June 2022 in accordance with 16 TAC § 25.53(f).
- 8. An appropriate summary of CRW and Keechi's Plans have been distributed to local jurisdictions as needed.

9. CRW and Keechi maintain a business continuity plan that addresses returning to normal operations after disruptions caused by an incident. Both the CRW and Keechi Plans serve as the business continuity plans for each project. The Plans address returning to normal operations after disruptions caused by an incident.




10. CRW and Keechi have trained their emergency management personnel who are designated to interact with local, state, and federal emergency management officials during emergency events on the latest IS-100, IS-200, IS-700, and IS-800 National Incident Management System training.


