2023 ANNUAL REVIEW STATEMENT FOR ELECTRIC SERVICE JOINT EMERGENCY OPERATIONS PLAN OF CALPINE CORPORATION, CALPINE POWERAMERICA, LLC, CHAMPION ENERGY SERVICES, LLC AND CALPINE SOLUTIONS, LLC

Pursuant to 16 Tex. Admin. Code § 25.53 Calpine Corporation (PGC Certificate No. 20008), Calpine PowerAmerica, LLC (REP Certificate No. 10015), Champion Energy Services, LLC (REP Certificate No. 10098), and Calpine Energy Solutions, LLC (REP Certificate No. 10017) (collectively, the PGC and REPs are referred to herein as "Calpine"), file this annual 2023 update to their Joint Emergency Operations Plan ("Joint EOP") under (c)(3)(B), and in support show as follows:

I. <u>CALPINE EMERGENCY CONTACTS</u>.

On April 18, 2022, Calpine filed its Joint EOP with the Public Utility Commission of Texas (the "Commission") in Project No. 53385, Project to Submit Emergency Operations Plans and Related Documents under 16 TAC §25.53.¹ Calpine has not made any changes to the list of primary or backup emergency contacts, including identification of specific individuals who can immediately address urgent requests and questions from the Commission during an emergency.

II. <u>CALPINE CONCURRENT REQUIRED SUBMISISONS.</u>

Calpine concurrently submits an attestation from the highest-ranking representative, official, or officer with binding authority over Calpine stating that no changes were made to the Joint EOP that materially affects how Calpine would respond to an emergency. Further, Calpine concurrently submits the affidavit required by Tex. Admin. Code § 25.53(c)(4)(C).

BEFORE ME, the undersigned authority, on this day personally appeared, John B. (Thad) Hill, who, after being duly sworn, stated that he is the highest-ranking representative, official, or officer with binding authority over the Power Generation Company ("PGC") and Retail Electric Providers ("REPs) identified above and that based on the best of his information, knowledge and belief the following are true and correct for the PGC and REPs:

- a. Relevant operating personnel for the PGC and REPs are familiar with and have received training on the applicable contents and execution of the Joint Emergency Operations Plan ("Joint EOP") which was filed with the Public Utility Commission of Texas ("Commission") on April 18, 2022 as Item 329 in Project 53385, and such personnel are instructed to follow the applicable portions of the Joint EOP except to the extent deviations are appropriate as a result of specific circumstances during the course of an emergency;
- b. The PGC and REP executives responsible for maintaining and implementing the various specific plans, policies and procedures that collectively amount to the Joint EOP have reviewed and approved the Joint EOP;
- c. The PGC and REPs have conducted drills (a tabletop exercise) to the extent required by subsection (f) of § 25.53;
- d. As needed, the PGC and REPs have distributed the Joint EOP or an appropriate summary of the Joint EOP to local jurisdictions;
- e. The PGC and REPs through their Joint EOP maintain business continuity plans that address returning to normal operations after disruptions caused by an incident; and
- f. The PGC's and REPs' respective emergency management personnel who are designated to interact with local, state, and federal emergency management officials during relevant events have received National Incident Management Training, specifically IS-100, IS-200, IS-700 and IS-800.
