In accordance with 16 Tex. Admin. Code §25.53, as amended by order of the Commission issued February 25, 2022 in Project No. 51841, RWE Clean Energy, LLC (RWECE) hereby submits the annual filing regarding its Emergency Operations Plan (EOP). During this reporting period (2022), RWECE was known as RWE Renewables Americas, LLC.

RWECE's EOP applies to each of the wholly-owned subsidiaries of RWECE which have Power Generation Company (PGC) registrations approved by the PUCT ("RWE Generators"), listed below:

AFFIDAVIT

BEFORE ME, the undersigned authority on this 10th day of March, 2023, personally appeared Tim Nelson, who being me duly sworn on oath deposed and said:

- My name is Tim Nelson. My position with RWE Clean Energy, LLC (RWECE) is Executive Vice President, Onshore Wind, Solar, Storage Operations. In that position, I am an officer and have binding signatory authority for each RWECE entity which is a Power Generation Company (PGC) registered with the Public Utility Commission of Texas.
- 2. During calendar year 2022, RWECE did not make a change to its EOP that materially affects how each of the RWE Generators would respond to an emergency.
- 3. Relevant operating personnel at RWECE are familiar with and have received training on the applicable contents and execution of the EOP, and such personnel are instructed to follow the applicable portions of the EOP except to the extent deviations are appropriate as a result of specific circumstances during the course of an emergency.
- 4. RWERA's EOP has been reviewed and approved by the appropriate executives.
- 5. Drills are regularly conducted to the extent required by $\S25.53(f)$.
- 6. RWERA's EOP or an appropriate summary is distributed to local jurisdictions as needed.
- 7. RWERA maintains a business continuity plan that addresses returning to normal operations after disruptions caused by an incident.
- 8. RWERA's emergency management personnel who are designated to interact with local, state, and federal emergency management officials during emergency events have received the latest IS-100. IS-200, IS-700, and IS-800 National Incident Management System training.


