## **AFFIDAVIT**

Before me, the undersigned authority, personally appeared Richard Booth who, being by me duly sworn, deposed as follows:

- 1. My name is Richard Booth. I am at least 18 years old, of sound mind, capable of making this affidavit, and personally acquainted with the facts herein stated.
- 2. I am currently employed as President of Arrow Energy TX LLC (Arrow). In this position, I have binding authority over Arrow.
- 3. Arrow is an Option I retail electric provider operating under Public Utility Commission of Texas (PUC) certificate number 10303.
- 4. This affidavit is submitted to satisfy the requirements of 16 Texas Administrative Code (TAC) § 25.53(c)(3)(B).
- 5. Arrow has not made any changes to its Emergency Operations Plan (EOP) that materially affect how it would respond to an emergency.
- 6. The relevant operating personnel at Arrow are familiar with, and have received training on, the applicable contents and execution of the EOP. The personnel who have received training have been instructed to follow the applicable portions of the EOP except to the extent deviations are appropriate as a result of specific circumstances during the course of an emergency.
- 7. The EOP has been reviewed and approved by the appropriate executives at Arrow.
- 8. Arrow has activated portions of its EOP to the extent required by 16 TAC § 25.53(f).
- 9. A copy of the EOP has been distributed to local jurisdictions as needed.
- 10. Arrow maintains a business continuity plan that addresses returning to normal operations after disruptions caused by an incident.

- 11. Arrow does not have any emergency management personnel who are designated to interact with local, state, and federal emergency management officials during emergency events who have all received the latest IS-100, IS-200, IS-700, and IS-800 National Incident Management System training. Any emergency management personnel designated in the future will complete the required training prior to interacting with any of the designated officials during an emergency.
- 12. I affirm that the information submitted in this affidavit is true and accurate.
