


BEFORE ME, the undersigned authority, on this day personally appeared John Adams who swore an oath that the following facts are true:

1. My name is John Adams. I am the Chief Executive Officer of Wolf Hollow I Power, LLC ("Wolf Hollow") and the highest-ranking officer with binding authority over Wolf Hollow. I am over 18 years of age, of sound mind, and competent and authorized to make this affidavit on behalf of Wolf Hollow. I have personal knowledge of the matters described herein.
2. Wolf Hollow is registered with the Public Utility Commission of Texas as a power generation company.
3. Wolf Hollow filed an emergency operations plan (the "Plan") in accordance with 16 Texas Administrative Code ("TAC") § 25.53 on April 14, 2022 and supplemented this filing on April 20, 2022.
4. No changes have been made to the Plan that materially affect how Wolf Hollow would respond to an emergency since Wolf Hollow's filing on April 14, 2022.
5. The relevant operating personnel are familiar with and have received training on the applicable contents and execution of the Plan, and such personnel are instructed to follow the applicable portions of the Plan except to the extent deviations are appropriate as a result of specific circumstances during the course of an emergency.
6. The Plan has been reviewed and approved by the appropriate executives.
7. A drill has been conducted in accordance with 16 TAC § 25.53(f).
8. The Plan or an appropriate summary has been distributed to local jurisdictions as needed.
9. Wolf Hollow maintains a business continuity plan that addresses returning to normal operations after disruptions caused by an incident.
10. The Wolf Hollow emergency management personnel who are designated to interact with local, state, and federal emergency management officials during emergency events have received the latest IS-100, IS-200, IS-700, and IS-800 National Incident Management System training.
