**GIGA ENERGY STORAGE, LLC'S ANNUAL UPDATE TO ITS EMERGENCY
OPERATIONS PLAN PURSUANT TO PUC SUBST. R. 25.53(c)(3) FOR 2023**

Giga Energy Storage, LLC (“Giga”) hereby submits its annual Emergency Operations Plan (“EOP”) update pursuant to 16 Tex. Admin. Code (“TAC”) § 25.53(c)(3). This update applies to Giga which is a Power Generation Company registered with the Public Utility Commission of Texas under registration number 20668. As supported by the attached Affidavit, Giga made no changes to its EOP in the previous calendar year that materially affect how it would respond to an emergency. Giga continues to comply with all applicable provisions of 16 TAC § 25.53 regarding its existing EOP that was previously submitted to the PUCT and to ERCOT.¹ Further, Giga has no changes to its emergency contact list.

Lastly, Giga has attached both an Attestation of its highest-ranking representative in compliance with 16 TAC § 25.53(c)(3)(B)(ii) and an affidavit of its highest-ranking representative in compliance with 16 TAC § 25.53(c)(3)(B)(iii).²

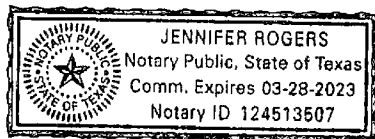

My name is JT Boone. I am the President, and authorized signatory for Giga Energy Storage, LLC ("Giga"). As President for Giga, I affirm that am the highest-ranking representative, official, or officer with binding authority over Giga. I am competent to testify to all the facts stated in this Affidavit, and I have the authority to make this Affidavit on behalf of Giga.

I swear or affirm that in my capacity as President of Giga, I have personal knowledge of the facts stated in the Emergency Operations Plan ("EOP") submitted to ERCOT and filed in Project No. 53385, of the facts included in Giga's 2023 Annual EOP Update pleading, and of the facts included in this Affidavit.

Pursuant to 16 Tex. Admin. Code ("TAC") § 25.53(c)(4)(C), I further swear and affirm that: (i) the site has not been constructed or interconnected to the grid yet and has an expected construction date of August 2023 and is expected to enter operations in November 2023. A draft EOP has been written in anticipation of construction and operations. Relevant operating personnel will be familiar with and will receive training on the applicable contents and execution of the EOP, and such personnel will be instructed to follow the applicable portions of the EOP except to the extent deviations are appropriate as a result of specific circumstances during the course of an emergency; (ii) the EOP has been reviewed and approved by the appropriate executives; (iii) drills are planned to be conducted in September of 2023 prior to entering commercial operations as required by 16 TAC § 25.53(f); (iv) the draft EOP or an appropriate summary has been distributed to local jurisdictions as needed; (v) that Giga maintains a business continuity plan that addresses returning to normal operations after disruption caused by an incident; and (vi) Giga's emergency management personnel who are designated to interact with local, state, and federal emergency management officials during emergency events have received the latest IS-100, IS-200, IS-700, and IS-800 National Incident Management Systems training.

I further swear of affirm the information, statements and/or representations contained in the EOP are true, complete, and correct to the best of my knowledge and belief.

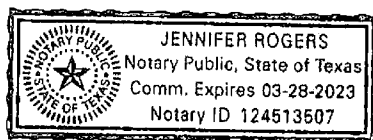
