AMMPER POWER, LLC'S ANNUAL UPDATE TO ITS EMERGENCY OPERATIONS PLAN PURSUANT TO PUC SUBST. R. 25.53(c)(3) FOR 2023

Ammper Power, LLC ("Ammper") hereby submits its annual Emergency Operations Plan ("EOP") update pursuant to 16 Tex. Admin. Code ("TAC") § 25.53(c)(3). This update applies to Ammper (REP Certification No. 10310). As supported by the attached Affidavit, Ammper made no changes to its EOP in the previous calendar year that materially affects how it would respond to an emergency. Ammper continues to comply with all applicable provisions of 16 TAC § 25.53 regarding its existing EOP that was previously submitted to the PUCT and to ERCOT.¹ Further, Ammper has no changes to its emergency contact list.

Lastly, Ammper has attached both an Attestation of its highest-ranking representative in compliance with 16 TAC § 25.53(c)(3)(B)(ii) and an affidavit of its highest-ranking representative in compliance with 16 TAC § 25.53(c)(3)(B)(iii).²




