

BEFORE ME, the undersigned authority, on this day personally appeared Suminori Arima who swore an oath that the following facts are true:


1. My name is Suminori Arima. I am a Director of GSF Americas Inc. ("GSF Americas") and the highest-ranking officer with binding authority over Sweetwater ESS Assets, LLC ("Sweetwater ESS"). I am over 18 years of age, of sound mind, and competent and authorized to make this affidavit on behalf of Sweetwater ESS. I have personal knowledge of the matters described herein.
2. Sweetwater ESS is registered with the Public Utility Commission of Texas as a power generation company and is a wholly owned subsidiary of GSF Americas. The Sweetwater ESS facility is a battery energy storage system.
3. Pursuant to 16 Texas Administrative Code ("TAC") § 25.53, Sweetwater ESS filed an emergency operations plan (the "Plan") on May 26, 2022.
4. No changes have been made to the plan that materially affect how Sweetwater ESS would respond to an emergency since Sweetwater ESS's filing on May 26, 2022.
5. The relevant operating personnel are familiar with and have received training on the applicable contents and execution of the Plan, and such personnel are instructed to follow the applicable portions of the Plan except to the extent deviations are appropriate as a result of specific circumstances during the course of an emergency.
6. The Plan has been reviewed and approved by the appropriate executives.
7. A drill has been conducted in accordance with 16 TAC § 25.53(f).
8. The Plan or an appropriate summary has been distributed to local jurisdictions as needed.
9. Sweetwater ESS maintains a business continuity plan that addresses returning to normal operations after disruptions caused by an incident.
10. Sweetwater ESS emergency management personnel who are designated to interact with local, state, and federal emergency management officials during emergency events have received the latest IS-100, IS-200, IS-700, and IS-800 National Incident Management System training.
