Dear Ms. Kirkland:

Oncor Electric Delivery Company LLC ("Oncor") is submitting the enclosed documents for filing in the above-referenced project consistent with the requirements of 16 Tex. Admin. Code § 25.53(c)(3)(B) ("TAC"). That provision requires an entity that, in the previous calendar year, did not make a change to its Emergency Operations Plan ("EOP") that materially affects how the entity would respond to an emergency to file the designated documents with the Commission. Because Oncor has not made a change to its EOP that materially affects how Oncor would respond to an emergency, Oncor is submitting the documents listed below for filing consistent with 16 TAC § 25.53(c)(3)(B).

- 1. Attestation signed by Oncor's Chief Executive Officer, E. Allen Nye, Jr. Pursuant to 16 TAC § 25.53(c)(3)(B)(ii) stating that Oncor did not make a change to its EOP that materially affects how Oncor would respond to an emergency.
- 2. Affidavit of Oncor Electric Delivery Company LLC Pursuant to 16 Tex. Admin. Code § 25.53(c)(3)(B)(iii) executed by Oncor's Chief Executive Officer, E. Allen Nye, Jr. affirming the provisions contained in 16 TAC § 25.53(c)(4)(C)(i)-(vi).

- 1. My name is E. Allen Nye, Jr. I am the Chief Executive Officer of Oncor Electric Delivery Company LLC ("Oncor"). I am of legal age and a resident of the State of Texas. I am Oncor's highest-ranking officer with binding authority over Oncor.
- 2. Oncor's relevant operating personnel are familiar with and have received training on the applicable contents and execution of the Oncor's Amended Public Utility Commission of Texas Emergency Operations Plan ("Oncor Amended PUC EOP"), and those personnel are instructed to follow the applicable portions of the Oncor PUC EOP except to the extent deviations are appropriate as a result of specific circumstances during the course of an emergency.
- 3. The Oncor Amended PUC EOP has been reviewed and approved by the appropriate Oncor executives.
- 4. Drills concerning the Oncor Amended PUC EOP have been conducted to the extent required by 16 Tex. Admin. Code § 25.53(f).
- 5. The Oncor Amended PUC EOP or an appropriate summary has been distributed to local jurisdictions as needed.
- 6. Oncor maintains a business continuity plan that addresses returning to normal operations after disruptions caused by an incident.
- 7. Oncor's emergency management personnel who are designated to interact with local, state, and federal emergency management officials during emergency events have received the latest IS-100, IS-200, IS-700, and IS-800 National Incident Management System training.
