AFFIDAVIT

Before me, the undersigned authority, personally appeared Matthew White, who, being by me duly sworn, deposed as follows:

- 1. My name is Matthew White. I am of sound mind, capable of making this affidavit, and personally acquainted with the facts herein stated.
- 2. I am currently employed as Chief Legal Officer of Accent Energy Texas, LP (Accent). In this position, I have binding authority over Accent Energy.
- 3. Accent Energy is an Option I retail electric provider operating under Public Utility Commission of Texas certificate number 10078.
- This affidavit is submitted to satisfy the requirements of 16 Texas Administrative Code § 25.53(c)(3)(B).
- 5. Accent Energy has not made any changes to its Emergency Operations Plan (EOP) that materially affect how it would respond to an emergency.
- 6. The relevant operating personnel at Accent Energy and its affiliates are familiar with, and have received training on, the applicable contents and execution of the EOP. The personnel who have received training have been instructed to follow the applicable portions of the EOP except to the extent deviations are appropriate as a result of specific circumstances during the course of an emergency.
- 7. The EOP has been reviewed and approved by the appropriate executives at Accent Energy.
- 8. Accent conducted a drill to test its EOP on August 29, 2022. Written notice of the drill was provided to Commission Staff and the appropriate TDEM District Coordinators at least 30 days in advance.
- 9. A copy of the EOP has been distributed to local jurisdictions as needed.

- 10. Accent Energy maintains a business continuity plan that addresses returning to normal operations after disruptions caused by an incident.
- 11. Accent Energy has one emergency management personnel who is designated to interact with local, state, and federal emergency management officials during emergency events and who has received the latest IS-100, IS-200, IS-700, and IS-800 National Incident Management System training. Any additional emergency management personnel designated in the future will complete the required training prior to interacting with any of the designated officials during an emergency.
- 12. I affirm that the information submitted in this affidavit is true and accurate.
