#### <u>AFFIDAVIT</u>

Before me, the undersigned authority, personally appeared Randal Miller who, being by me duly sworn, deposed as follows:

- 1. My name is Randal Miller. I am over 18 years old, of sound mind, capable of making this affidavit, and personally acquainted with the facts herein stated.
- 2. I am currently employed as CEO of Southern Federal Power, LLC (Southern Federal). In this position, I have binding authority over Southern Federal and Town Square Energy, LLC (Town Square).
- 3. Southern Federal is an Option 1 retail electric provider operating under Public Utility Commission of Texas (PUC) certificate number 10264.
- 4. Town Square is an Option I retail electric provider that holds (PUC) certificate number 10258.
- This affidavit is submitted to satisfy the requirements of 16 Texas Administrative Code § 25.53(c)(3)(B).
- 6. No changes have been made to the Emergency Operations Plan (EOP) that would materially affect how Southern Federal and Town Square would respond to an emergency.
- 7. The relevant operating personnel at Southern Federal and Town Square are familiar with, and have received training on, the applicable contents and execution of the EOP. The personnel who have received training have been instructed to follow the applicable portions of the EOP except to the extent deviations are appropriate as a result of specific circumstances during the course of an emergency.
- 8. The EOP has been reviewed and approved by the appropriate executives at Southern Federal and Town Square.

- Southern Federal and Town Square conducted a drill to test the EOP, including a test of the Hurricane Annex, on June 10, 2022. Written notice of the drill was provided to Commission Staff and the appropriate TDEM District Coordinators at least 30 days in advance of the drill.
- 10. A copy of the EOP has been distributed to local jurisdictions as needed.
- 11. Southern Federal and Town Square maintain a business continuity plan that addresses returning to normal operations after disruptions caused by an incident.
- 12. Southern Federal and Town Square have two emergency management personnel who are designated to interact with local, state, and federal emergency management officials during emergency events who have all received the latest IS-100, IS-200, IS-700, and IS-800 National Incident Management System training. Any additional emergency management personnel designated in the future will complete the required training prior to interacting with any of the designated officials during an emergency.
- 13. I affirm that the information submitted in this affidavit is true and accurate.
