PROJECT TO SUBMIT EMERGENCY OPERATIONS PLANS AND RELATED DOCUMENTS UNDER 16 TAC § 25.53 **§ PUBLIC UTILITY COMMISSION OF TEXAS**

Bull Creek Wind LLC (“BCW”) hereby submits its annual Emergency Operations Plan (“EOP”) update pursuant to 16 Tex. Admin. Code (“TAC”) § 25.53(c)(3). This update applies to the BCW power generation company (PGC Certification No. 20228). As supported by the attached Affidavit, BCW made no changes to its EOP in the previous calendar year that materially affect how it would respond to an emergency. BCW continues to comply with all applicable provisions of 16 TAC § 25.53 regarding its existing EOP that was previously submitted to the PUCT and to ERCOT.¹ Further, BCW has made various changes to its emergency contact list, which it hereby reports to the Commission pursuant to 16 TAC § 25.53(c)(3)(B)(i) in Attachment A to this pleading.

Additionally, BCW confidentially submits an updated complete list of its emergency contacts for the Commission's reference.

BCW has also attached both an Attestation of its highest-ranking representative in compliance with 16 TAC § 25.53(c)(3)(B)(ii) and an affidavit of its highest-ranking representative in compliance with 16 TAC § 25.53(c)(3)(B)(iii).²
