Trinity Hills Wind Farm LLC (“Trinity Hills”), PGC No. 20277, hereby submits its annual Emergency Operations Plan (“EOP”) update pursuant to 16 Tex. Admin. Code (“TAC”) § 25.53(c)(3). As supported by the attached Affidavit, Trinity Hills made no changes to its EOP in the previous calendar year that materially affects how it would respond to an emergency. Trinity Hills continues to comply with all applicable provisions of 16 TAC § 25.53 regarding its existing EOP that was previously submitted to the PUCT and to ERCOT. Further, Trinity Hills made the following change to its emergency contact list: change in contact information for Mr. Brandon Diaz, which it hereby reports to the Commission pursuant to 16 TAC § 25.53(c)(3)(B)(i). Mr. Diaz’ contact information has been filed confidentially as an attachment to this pleading.

Lastly, Trinity Hills has attached both an Attestation of its highest-ranking representative in compliance with 16 TAC § 25.53(c)(3)(B)(ii) and an affidavit of its highest-ranking representative in compliance with 16 TAC § 25.53(c)(3)(B)(iii).<sup>1</sup>

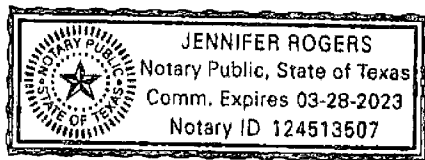

Code ("TAC") § 25.53(c)(4)(C), I further swear and affirm that: (i) all relevant operating personnel are familiar with and have received training on the applicable contents and execution of the EOP, and such personnel are instructed to follow the applicable portions of the EOP except to the extent deviations are appropriate as a result of specific circumstances during the course of an emergency; (ii) the EOP has been reviewed and approved by the appropriate executives; (iii) drills have been conducted to the extent required by 16 TAC § 25.53(f); (iv) the EOP or an appropriate summary has been distributed to local jurisdictions as needed; (v) that Trinity Hills maintains a business continuity plan that addresses returning to normal operations after disruption caused by an incident; and (vi) Trinity Hill's emergency management personnel who are designated to interact with local, state, and federal emergency management officials during emergency events have received the latest IS-100, IS-200, IS-700, and IS-800 National Incident Management Systems training.

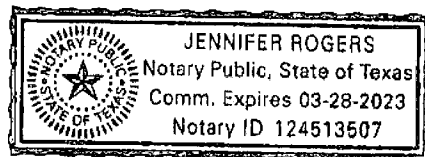
