**TESLA ENERGY VENTURES, LLC ANNUAL UPDATE TO ITS EMERGENCY  
OPERATIONS PLAN  
PURSUANT TO PUC SUBST. R. 25.53(c)(3) FOR 2023**

Tesla Energy Ventures, LLC (“TEV”) hereby submits its annual Emergency Operations Plan (“EOP”) update pursuant to 16 Tex. Admin. Code (“TAC”) § 25.53(c)(3). This update applies to all retail electric providers included in TEV’s previously-submitted EOP, which include: Tesla Energy Ventures, LLC. As supported by the attached Affidavit, TEV made no changes to its EOP in the previous calendar year that materially affects how it would respond to an emergency. TEV continues to comply with all applicable provisions of 16 TAC § 25.53 regarding its existing EOP that was previously submitted to the PUCT and to ERCOT. Further, TEV made the following change to its emergency contact list: addition of Jesse Argon de Galvez, which it hereby reports to the Commission pursuant to 16 TAC § 25.53(c)(3)(B)(i). Mr. Argon de Galvez’s contact information has been filed confidentially as an attachment to this pleading.

Lastly, TEV has attached both an Attestation of its highest-ranking representative in compliance with 16 TAC § 25.53(c)(3)(B)(ii) and an affidavit of its highest-ranking representative in compliance with 16 TAC § 25.53(c)(3)(B)(iii).<sup>1</sup>



I further swear of affirm the information, statements and/or representations contained in the EOP are true, complete, and correct to the best of my knowledge and belief.




