**TG EAST WIND PROJECT, LLC ANNUAL UPDATE TO ITS EMERGENCY
OPERATIONS PLAN
PURSUANT TO PUC SUBST. R. 25.53(c)(3) FOR 2023**

TG EAST WIND PROJECT, LLC (“TG EAST”) hereby submits its annual Emergency Operations Plan (“EOP”) update pursuant to 16 Tex. Admin. Code (“TAC”) § 25.53(c)(3). This update applies to all power generation companies included in TG EAST’s previously-submitted EOP, which include: TGEAST WIND PROJECT, LLC (Registration No. 20637). TG EAST made no changes to its EOP in the previous calendar year that materially affect how it would respond to an emergency. TG EAST continues to comply with all applicable provisions of 16 TAC § 25.53 regarding its existing EOP that was previously submitted to the PUCT and to ERCOT. Further, TG EAST has made the following changes to its emergency contact list, which it hereby reports to the Commission pursuant to 16 TAC § 25.53(c)(3)(B)(i):

- Removal of David Arendol and Whitney Kirk
- Addition of Luke Hibner and Lyrae Anderson

The contact information for Luke Hibner and Lyrae Anderson is being provided in the confidential list of updated emergency contacts for TG EAST also submitted with this annual update.

Due to unforeseen circumstances, TG EAST is unable to provide the attestation of its highest-ranking representative in compliance with 16 TAC § 25.53(c)(3)(B)(ii) and an affidavit of its highest-ranking representative in compliance with 16 TAC § 25.53(c)(3)(B)(iii). To the extent

required, TG EAST respectfully requests good cause under 16 TAC § 22.4(b) for an extension of time to file its attestation and affidavit. TG EAST will file both documents as soon as possible.
