SPINNING SPUR WIND THREE LLC'S EMERGENCY OPERATIONS PLAN

Pursuant to 16 Texas Administrative Code ("TAC") § 25.53(c)(3)(B), Spinning Spur Wind Three LLC ("Spinning Spur Wind Three") hereby files an updated list of emergency contacts and required affidavit.

On December 29, 2022, Boralex US Wind TNM LLC, a wholly owned indirect subsidiary of Boralex Inc., acquired from EDF Renewables Asset Holdings, Inc. ("EDF") the managing member interest held by EDF in LongSpur Wind Holdings, LLC, which in turn is the managing member of Spinning Spur Wind Three (the "Transaction").

EDF continues to provide project administration services and operations and maintenance services to Spinning Spur Wind Three after closing of the Transaction. Consequently, Spinning Spur Wind Three's Emergency Preparedness and Response Plan (the "Plan") has not been modified as a result of the Transaction, nor has there otherwise been any change to the Plan that materially affects how Spinning Spur Wind Three would respond to an emergency. There has been no change to the emergency contact list.

BEFORE ME, the undersigned authority, on this day personally appeared who swore an oath that the following facts are true:

- 1. My name is Patrick Decostre. I am the President and CEO at Boralex Inc., and the highest-ranking representative, official, or officer with binding authority over Spinning Spur Wind Three LLC ("Spinning Spur Wind Three"). I am over 18 years of age, of sound mind, and competent and authorized to make this affidavit on behalf of Spinning Spur Wind Three. I have personal knowledge of the matters described herein.
- 2. Spinning Spur Wind Three is registered with the Public Utility Commission of Texas as a power generation company. Spinning Spur Wind Three is an indirect affiliate of Boralex Inc.
- 3. Spinning Spur Wind Three has in place an emergency operations plan (the "Plan") in accordance with 16 Texas Administrative Code ("TAC") § 25.53.
- 4. The Plan has been reviewed and approved by the appropriate executives.
- 5. EDF Renewables Asset Holdings, Inc. ("EDF"), in its capacity as project administrator and operation and maintenance service provider, has confirmed the following:
 - All relevant operating personnel are familiar with and have received training on the applicable contents and execution of the Plan, and such personnel are instructed to follow the applicable portions of the Plan except to the extent deviations are appropriate as a result of specific circumstances during the course of an emergency.
 - The Plan has been reviewed and approved by the appropriate EDF executives.
 - Spinning Spur Wind Three conducted a drill on its Plan on September 13, 2022 consistent with the requirement in 16 TAC § 25.53(f).
 - The Plan or an appropriate summary has been distributed to local jurisdictions as needed.
 - Spinning Spur Wind Three maintains a business continuity plan that addresses returning to normal operations after disruptions caused by an incident.

• EDF emergency management personnel who are designated to interact with local, state, and federal emergency management officials during emergency events have received the latest IS-100, IS-200, IS-700, and IS-800 National Incident Management System training.
