Additionally, DERS submits the following affidavit in accordance with 16 TAC § 25.53(c)(3)(B).

AFFIDAVIT OF ERNEST KAPOPOULOS

- I. My name is Ernest Kapopoulos. I am over the age of 18 and fully competent to make this affidavit.
- II. I am employed by Duke Energy Renewable Services, LLC ("DERS") as Vice President Renewable Operations, and I am a member of DERS' Senior Leadership Team.
- III. As Vice President Renewable Operations for DERS, my responsibilities include overseeing: i) all maintenance and operations, ii) all system operations and measurement activities, and iii) all emergency operations, including DERS' Emergency Operations Plan ("EOP").
- IV. This affidavit is submitted to satisfy the requirements of 16 Texas Administrative Code § 25.53(c)(3)(B)
- V. DERS has not made any changes to its EOP that materially affect how it would respond to an emergency.
- VI. I affirm that all relevant operating personnel at DERS are familiar with the contents and have been trained on DERS' EOP.
- VII. I affirm that all relevant operating personnel at DERS are committed to following DERS' EOP, except to the extent deviations are appropriate under the circumstances during the course of an emergency.
- VIII. I affirm that that the EOP has been reviewed and approved by the appropriate DERS executives.
- IX. I affirm that drills have been conducted by the extent required by 16 TAC § 25.53(f) ELECTRIC SERVICE EMERGENCY OPERATIONS PLANS.
- X. I affirm that that the EOP or an appropriate summary has been distributed to local jurisdictions as needed.
- XI. I affirm that DERS maintains a business continuity plan that addresses returning to normal operations after disruptions caused by an incident.
- XII. I affirm that Duke Energy's emergency management personnel who are designated to interact with local, state, and federal emergency management officials during emergency events have receive the latest IS-100, IS-200, IS-700, and IS-800 National Incident Management System.
