4. The EOP has been reviewed by appropriate executives at MP2 Energy Texas LLC d/b/a/ Shell Energy Solutions.
5. MP2 Energy Texas LLC d/b/a/ Shell Energy Solutions has conducted drills on the EOP in accordance with 16 Texas Administrative Code § 25.53(f).
6. The EOP or an appropriate summary has been distributed to local jurisdictions as needed.
7. MP2 Energy Texas LLC d/b/a/ Shell Energy Solutions maintains a business continuity plan that addresses returning to normal after disruptions caused by an incident.

8. MP2 Energy Texas LLC d/b/a/ Shell Energy Solutions' emergency management personnel who are designated to interact with local, state, and federal emergency management officials during emergency events have received the latest IS-100, IS-200, IS-700, and IS-800 National Incident Management System training.

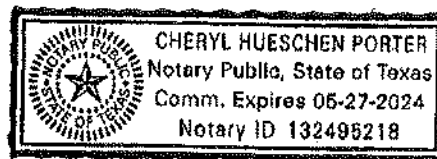


