- 3. All relevant operating personnel are familiar with and have received training on portions of the Emergency Operations Plan ("EOP") applicable to assigned duties and such personnel are instructed to follow the applicable portions of the EOP to the extent that deviations are appropriate as a result of specific circumstances during the course of an emergency.
- 4. The EOP has been reviewed by appropriate executives at Pulse Power LLC.
- 5. Pulse Power LLC has conducted drills on the EOP in accordance with 16 Texas Administrative Code § 25.53(f).
- 6. The EOP or an appropriate summary has been distributed to local jurisdictions as needed.
- 7. Pulse Power LLC maintains a business continuity plan that addresses returning to normal after disruptions caused by an incident.
- 8. Pulse Power LLC's emergency management personnel who are designated to interact with local, state, and federal emergency management officials during emergency events have

received the latest IS-100, IS-200, IS-700, and IS-800 National Incident Management System training.
