**TO THE HONORABLE PUBLIC UTILITY COMMISSION OF TEXAS:**

Pursuant to 16 Tex. Admin. Code § 25.53(f) ("TAC"), by this correspondence Oncor Electric Delivery Company LLC ("Oncor") is providing the Public Utility Commission of Texas with notification that in addition to its planned participation in the North American Electric Reliability Corporation's (NERC) "GridEx" Drill (November 14 and 15), Oncor will conduct a separate internal **"Major Storm Drill"** to test its emergency storm restoration procedures. This drill be conducted on November 8, 2023, from approximately 8:00 AM to 1:00 PM.

Oncor's participation in these drill activities will be administered from its secure System Emergency Center (SEC) location with participation and responsive drill activities occurring at various Oncor operating centers and locations throughout its system.

Pursuant to 16 TAC § 25.53(f), Oncor has notified the appropriate Texas Division of Emergency Management (TDEM) District Coordinators in Oncor's service area (via email) of the date, time, and location of the referenced drill at least 30 days prior to the date of the drill.
