"I am the Chief Executive Officer of Central Texas Electric Cooperative, Inc. (CTEC), which is a Texas electric cooperative corporation.

CTEC operates an electric distribution utility system in the State of Texas and the Electric Reliability Council of Texas power region.

The Emergency Operations Plan (EOP) developed to comply with the updated 16 TAC §25.53. Electric Service Emergency Operations Plan Rule, has been distributed to CTEC Managers and Operations personnel;

CTEC executives, and Operations personnel have received training on the updated EOP;



CTEC has distributed the EOP to local Jurisdictions, including regional TDEM personnel and all Counties in the CTEC service area;

CTEC has a Business Continuity Plan related to returning to normal operations after an emergency event or situation;


