

1.0 Plan Revisions / Approval(s)

This version of the SBEC Emergency Operations Plan (EOP) was developed to comply with the updated 16 TAC §25.53. Electric Service Emergency Operations Plan Rule, that was approved by the Texas Public Utility Commission on February 25, 2022. The updated 16 TAC §25.53 made several significant changes to the existing rule based on issues identified after the Winter Storm Uri / ERCOT Load Shed Emergency during February-2021.

The EOP is intended to provide SBEC with a clear set of guidelines, policies, and procedures intended to guide the Cooperative's preparations, responses, and actions related to all phases and types of electric system emergencies.

This Plan is a living document and shall be reviewed and updated on a regular basis. The CEO and the Electric System Manager are responsible for coordinating these systematic updates.

SBEC has a Business Continuity Plan related to returning to normal operations after an emergency event or situation;

SBEC's emergency management personnel who are designated to interact with local, state, and federal emergency management officials during emergency events have received the latest IS-100, IS-200, IS-700, and IS-800 National Incident Management System training.
