"I am the Interim City Manager for the City of Weimar (CoW), which is an incorporated municipality in the State of Texas."

CoW operates an electric distribution utility system in the State of Texas and the Electric Reliability Council of Texas power region.

The Emergency Operations Plan (EOP) developed to comply with the updated 16 TAC §25.53. Electric Service Emergency Operations Plan Rule, has been distributed to CoW Managers and Operations personnel;

CoW executives and Operations personnel have received training on the updated EOP;

CoW's emergency management personnel who are designated to interact with local, state, and federal emergency management officials during emergency events have received the latest IS-100, IS-200, IS-700, and IS-800 National Incident Management System training.
