"I am the City Manager for the City of Goldthwaite (COG), which is an incorporated municipality in the State of Texas."

COG operates an electric distribution utility system in the State of Texas and the Electric Reliability Council of Texas power region.

The Emergency Operations Plan (EOP) developed to comply with the updated 16 TAC §25.53, Electric Service Emergency Operations Plan Rule, has been distributed to COG Managers and Operations personnel;

COG executives and Operations personnel have received training on the updated EOP;


Drills have been conducted to the extent required by 16 TAC §25.53(f);

COG has a Business Continuity Plan related to returning to normal operations after an emergency event or situation;

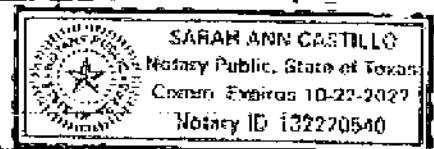
