
- 2. In accordance with PUCT Order 51841, I attest to the following:

  - d. The EOP, or an appropriate summary, has been distributed to local jurisdictions as needed;
  - e. EDF maintains a business continuity plan that addresses returning to normal operations after disruptions caused by an incident; and
  - f. Emergency management personnel who are designated to interact with local, state, and federal emergency management officials during emergency events have received the latest IS-100, IS-200, IS-700, and IS-800 National Incident Management System training."

#### **Executive Summary – EOP**

EDF Trading North America, LLC and EDF Energy Services, LLC, (collectively "EDF"), submit the attached EDF Trading North America Business Continuity Plan as EDF's Emergency Operations Plan ("EOP") in compliance with PUCT Order 51841. The EOP addresses numerous situations in which normal operations would continue to function in the event of potential or actual emergencies. The attached EOP is provided to the EDF's leadership team for review and training on no less than an annual basis. In accordance with Order 51841, the following is a summary of the required elements of an emergency operations plan as set forth in the Order, and such elements may be found in the EOP at the page numbers referenced below:

- Names and titles of EDF's employees that receive access and training to EOP; (pg 5); Most recent training occurred in December of 2021.
- Communications protocols with public, media, customers, the commission, and OPUC (pg 17)
- Emergency supply management (pg 15)
- Identification of weather events (pg 17)
- Pandemic and epidemic annex (pg 23)
- Hurricane annex (pg 17 & 20)
- Cyber security annex (pg 25)
- Physical security incident annex (pg 29)
- Primary contact person (pg 41)
