BEFORE ME, the undersigned authority in the State of Texas, on this day personally appeared Josh Schroeder, the Mayor of the City of Georgetown, who swore or affirmed to tell the truth, and stated as follows:

- My name is Josh Schroeder. I am of sound mind, older than 18 years of age, and 1. capable of making this sworn statement. I have personal knowledge of the facts written in this statement. I understand that if I lie in this statement, I may be held criminally responsible. This statement is true to the best of my knowledge.
- I am the Mayor of the City of Georgetown ("City"). In this role, I am the highest-2. ranking official with binding authority over the City.
- Subchapter C, Section 25.53 of the Texas Administrative Code, required 3. municipally owned utilities to file an emergency operations plan ("EOP") by June 1, 2022, and to annually update information in its EOP no later than March 15 under certain circumstances, I am generally familiar with the City's EOP, and therefore, affirm the following:
- a. Relevant operating personnel are familiar with and have received training on the applicable contents and execution of the EOP, and such personnel are instructed to follow the applicable portions of the EOP, except to the extent deviations are appropriate as a result of specific circumstances during the course of an emergency:

b. The EOP has been reviewed and approved by the City employees and officials;

c. Drills have been conducted to the extent required by 16 Texas Administrative Code § 25.53(f);

d. The EOP or an appropriate summary has been distributed to local jurisdictions as needed;

e. The City maintains a business continuity plan that addresses returning to normal operations after disruptions caused by an incident; and

f. The City's emergency management personnel who are designated to interact with local, state, and federal emergency management officials during emergency events have received the latest IS-100, IS-200, IS-700, and IS-800 National Incident Management System training.

g. The City did not make a change to its EOP that materially affects how the City would respond to an emergency.

h. There changes to the list of emergency contacts as provided under 16 Texas Administrative Code § 25.53(4)(B) is shown in the attached exhibit.

4. The above statements are true and accurate to the best of my knowledge.
