- 2. My name is Chris Leitner. I provide this Affidavit on behalf of Tenaska Frontier Partners, Ltd. (the "Project Company") in accordance with the provisions of subsection (c)(4)(C) of the EOP Substantive Rules. I am the Chief Executive Officer and President of Tenaska VI, Inc. (the "Managing Partner"), the managing general partner of Tenaska VI Partners, L.P., which entity is the managing general partner of the Project Company.
- 3. By this Affidavit, I am certifying that:
  - a. No changes have been made to the list of emergency contacts for Tenaska Frontier Partners Ltd.
  - b. No changes have been made to our EOP that materially affects how the entity would respond to an emergency.
  - c. Relevant operating personnel with respect to the Project Company are or will be familiar with and have received or will receive training on the applicable contents and execution of the EOP, and such personnel are or will be instructed to follow the applicable portions of the EOP except to the extent deviations are appropriate as a result of specific circumstances during the course of an emergency.
  - d. The EOP has been reviewed and approved by the appropriate executives of the Managing Partner for and on behalf of the Project Company.
  - e. Drills will be conducted to the extent required by subsection (f) of the EOP Substantive Rules.

- f. The EOP or an appropriate summary has been distributed to local jurisdictions as needed.
- g. The Project Company maintains a business continuity plan that addresses returning to normal operations after disruptions caused by an incident.
- h. The Project Company's emergency management personnel who are designated to interact with local, state, and federal emergency management officials during emergency events have received or will receive the latest IS-100, IS-200, IS-700 and IS-800 National Incident Management System training.
