“I am the General Manager & CEO for the Kerrville Public Utility Board (KPUB), which is a municipally owned electric utility, owned by the City of Kerrville, an incorporated municipality in the State of Texas.”

KPUB operates an electric distribution utility system in the State of Texas and the Electric Reliability Council of Texas power region.

The Emergency Operations Plan (EOP) developed to comply with the updated 16 TAC §25.53. Electric Service Emergency Operations Plan Rule, has been distributed to KPUB Managers and Operations personnel;

KPUB executives and Operations personnel have received training on the updated EOP;

KPUB has distributed the EOP to local Jurisdictions, including regional TDEM personnel and including Kerr County Emergency Management Coordinator;


KPUB has a Business Continuity Plan related to returning to normal operations after an emergency event or situation;

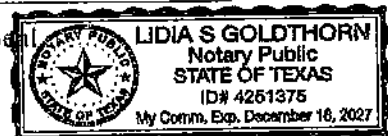


The §25.53 Electric Service Emergency Operations Plans Rule is applicable to KPUB.

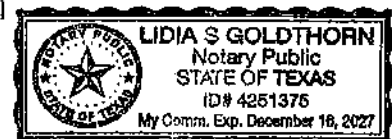
