BEFORE ME, the undersigned authority, on this day personally appeared the undersigned who, after being duly sworn, stated on his oath that he is entitled to make this Affidavit, and that the statements contained below are true and correct.

"My name is <u>Pat Wood, III</u>. I am the <u>Chief Executive Officer</u> of Hoef's Road L.L.C. ("Hoef's Rd."). My business address is 1900 N. Akard St., Dallas, TX 75201. I am the highest-ranking officer with binding authority over Hoef's Rd. I swear or affirm that I have personal knowledge of the facts set forth in this Affidavit. I am over 18 years of age and competent to make this affidavit.

Hoef's Rd. has an Emergency Operation Plan ("EOP"), prepared in accordance with Public Utility Commission of Texas Subst. Rule §25.53(c) ("Substantive Rule"). I attest and affirm that each of the following are true and accurate:

- 1. Hoef's Rd. personnel have reviewed the current Emergency Operations Plan and determined that the plan continues to support current operations. All changes to the plan did not materially alter how Hoef's Rd. would respond to any future emergencies.
- 2. All relevant operating personnel are familiar with and have received annual training on the contents and execution of the EOP, and such personnel are instructed to follow the EOP except to the extent deviations are appropriate under the circumstances, during the course of an emergency.
- 3. The EOP has been reviewed and approved by the appropriate executives.
- 4. Hoef's Rd. determined it was unnecessary to distribute the EOP to local jurisdictions at this time.
- 5. Hurricane drills required under the Substantive Rule were most recently completed on May 2, 2023 and will be conducted again on April 29, 2024, unless the EOP has been activated

in response to an emergency prior to the test.

- 6. Hoef's Rd. maintains a business continuity plan that addresses returning to normal operations after disruptions caused by an incident.
- The emergency management personnel who are designated by Hoef's Rd. to interact with local, state, and federal emergency management officials during emergency events have received National Incident Management System training, specifically IS-100, IS-200, IS-700, and IS-800
