HEN Power Marketing L.L.C. ("HEN PM") is the manager and operator of HEN Infrastructure and is responsible for maintaining and implementing the EOP.

HEN Infrastructure hereby gives notice that, effective March 4, 2024, HEN Infrastructure has made no changes to the Emergency Contacts as included in the HEN Infrastructure 2022 Emergency Operations Plan Executive Summary document which was filed with the Commission on April 18, 2022, pursuant to §25.53 Electric Service Emergency Operations Plans Docket 53385. HEN Infrastructure has reviewed the current Emergency Operations Plan and has not made any changes that materially affect how HEN Infrastructure would respond to an emergency, as attested to in the accompanying filing.

BEFORE ME, the undersigned authority, on this day personally appeared the undersigned who, after being duly sworn, stated on his oath that he is entitled to make this Affidavit, and that the statements contained below are true and correct.

"My name is <u>Pat Wood, III</u>. I am the <u>Chief Executive Officer</u> of HEN Infrastructure, L.L.C. ("HEN Infrastructure"). My business address is 1900 N. Akard St., Dallas, TX 75201. I am the highest-ranking officer with binding authority over HEN Infrastructure I swear or affirm that I have personal knowledge of the facts set forth in this Affidavit. I am over 18 years of age and competent to make this affidavit.

HEN Infrastructure has an Emergency Operation Plan ("EOP"), prepared in accordance with Public Utility Commission of Texas Subst. Rule §25.53(c) ("Substantive Rule"). I attest and affirm that each of the following are true and accurate:

- 1. HEN Infrastructure personnel have reviewed the current Emergency Operations Plan and determined that the plan continues to support current operations. All changes to the plan did not materially alter how HEN Infrastructure would respond to any future emergencies.
- 2. All relevant operating personnel are familiar with and have received annual training on the contents and execution of the EOP, and such personnel are instructed to follow the EOP except to the extent deviations are appropriate under the circumstances, during the course of an emergency.
- 3. The EOP has been reviewed and approved by the appropriate executives.
- 4. HEN Infrastructure determined it was unnecessary to distribute the EOP to local jurisdictions at this time.
- 5. Hurricane drills required under the Substantive Rule were most recently completed on May 2, 2023 and will be conducted again on April 29, 2024, unless the EOP has been activated


in response to an emergency prior to the test.

- 6. HEN Infrastructure maintains a business continuity plan that addresses returning to normal operations after disruptions caused by an incident.
- The emergency management personnel who are designated by HEN Infrastructure to interact with local, state, and federal emergency management officials during emergency events have received National Incident Management System training, specifically IS-100, IS-200, IS-700, and IS-800
