AFFIDAVIT

BEFORE ME, the undersigned authority, on this day personally appeared Robert Jozwiak who swore an oath that the following facts are true:

- 1. My name is Robert Jozwiak. I am the President of and highest-ranking representative, official, or officer with binding authority over Keechi Wind LLC ("Keechi"). I am over 18 years of age, of sound mind, and competent and authorized to make this affidavit on behalf of Keechi. I have personal knowledge of the matters described herein.
- 2. Keechi is registered with the Public Utility Commission of Texas as a Power Generation Company (Registration No. 20330). Keechi is wholly owned subsidiary of Enbridge, Inc.
- 3. Keechi filed an emergency operations plan (the "Plan") in accordance with 16 Texas Administrative Code ("TAC") § 25.53 on April 18, 2022.
- 4. No changes were made to the Plan that materially affects how Keechi would respond to an emergency since its filing on April 18, 2022.
- 5. All relevant operating personnel for Keechi are familiar with and have received training on the applicable contents and execution of the Plan, and such personnel are instructed to follow the applicable portions of the Plan except to the extent deviations are appropriate as a result of specific circumstances during the course of an emergency.
- 6. Keechi's Plan has been reviewed and approved by the appropriate executives.
- Keechi conducted a drill in December 2023 in accordance with 16 TAC § 25.53(f).
- 8. An appropriate summary of Keechi's Plan has been distributed to local jurisdictions as needed.
- Keechi maintains a business continuity plan that addresses returning to normal operations after disruptions caused by an incident. Keechi's Plan serves as the business continuity plan.

10. Keechi has trained its emergency management personnel who are designated to interact with local, state, and federal emergency management officials during emergency events on the latest IS-100, IS-200, IS-700, and IS- 800 National Incident Management System training.

- (a) Send a notice to eopdrillnotice@puc.texas.gov 30 days in advance of the drill. If the date is required to change, send a follow-up email to PUCT with the new date and the reason for the change.
- (b) File a notice with the PUCT under Project No. 53385. Follow up in the email notice to PUCT in the event we have to update the drill date for weather, etc. if a refile under Project No. 53385 is required.
- 2: In a drill notify to all personnel: Attention All Personal, Emergency, Emergency, Emergency, this is a drill, repeat this is a drill"
