





BEFORE ME, the undersigned authority, on this day personally appeared Robert Jozwiak who swore an oath that the following facts are true:

1. My name is Robert Jozwiak. I am the President of and highest-ranking representative, official, or officer with binding authority over Chapman Ranch Wind I LLC ("CRW"). I am over 18 years of age, of sound mind, and competent and authorized to make this affidavit on behalf of CRW. I have personal knowledge of the matters described herein.
2. CRW is registered with the Public Utility Commission of Texas as a Power Generation Company (Registration No. 20381). CRW is wholly owned subsidiary of Enbridge, Inc.
3. CRW filed an emergency operations plan (the "Plan") in accordance with 16 Texas Administrative Code ("TAC") § 25.53 on April 18, 2022.
4. No changes were made to the Plan that materially affects how CRW would respond to an emergency since its filing on April 18, 2022.
5. All relevant operating personnel for CRW are familiar with and have received training on the applicable contents and execution of the Plan, and such personnel are instructed to follow the applicable portions of the Plan except to the extent deviations are appropriate as a result of specific circumstances during the course of an emergency.
6. CRW's Plan has been reviewed and approved by the appropriate executives.
7. CRW conducted a drill of the Plan on October 23, 2023 in accordance with 16 TAC § 25.53(f).
8. An appropriate summary of CRW's Plan has been distributed to local jurisdictions as needed.
9. CRW maintains a business continuity plan that addresses returning to normal operations after disruptions caused by an incident. CRW's Plan serves as the business continuity plan.

10. CRW has trained its emergency management personnel who are designated to interact with local, state, and federal emergency management officials during emergency events on the latest IS-100, IS-200, IS-700, and IS- 800 National Incident Management System training.
