"I am the City Manager for the City of Liberty (COL), which is an incorporated home-rule municipality in the State of Texas."

COL operates an electric distribution utility system in the State of Texas.

The Emergency Operations Plan (EOP) developed to comply with the 16 TAC §25.53 Electric Service Emergency Operations Plans Rule, has been distributed to COL Managers and Operations personnel.

COL executives and Operations personnel have received training on the updated EOP;

Drills have been conducted to the extent required by 16 TAC §25.53(f);

The EOP has been reviewed and approved by the appropriate executives.

COL notified Commission Emergency Management Personnel and regional TDEM representative(s) prior to the drill;

COL has distributed the EOP to local Jurisdictions, including regional TDEM personnel and The Liberty County Emergency Management Coordinator.

COL has a Business Continuity Plan related to returning to normal operations after an emergency event or situation.

COL's emergency management personnel who are designated to interact with local, state, and federal emergency management officials during emergency events have received the latest IS-100, IS-200, IS-700, and IS-800 National Incident Management System training.

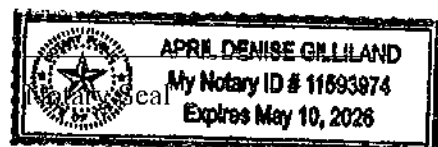

The §25.53. Electric Service Emergency Operations Plans Rule is applicable to COL.

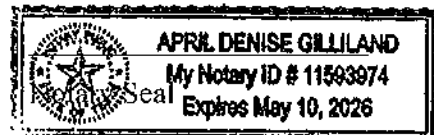


