*J*, Ryan Kelso, swear or affirm that as a Municipally Owned Utility operating in the State of Texas and the Electric Reliability Council of Texas (ERCOT) region and control system, confirms the following:

"I am the CEO for the New Braunfels Utilities (NBU), which is an incorporated municipality in the State of Texas,

NBU operates an electric transmission and distribution utility system in the State of Texas and the Electric Reliability Council of Texas power region.

The Emergency Operations Plan (EOP) developed to comply with the updated 16 TAC §25.53. Electric Service Emergency Operations Plan Rule, has been distributed to NBU Managers and Operations personnel;

NBU Executives and Operations personnel have received training on the updated EOP;

In accordance with the updated 16 TAC §25.53. Electric Service Emergency Operations Plan Rule, annually, a drill (tabletop exercise) for NBU Operations personnel will be conducted as required;

NBU will notify Commission Emergency Management Personnel and regional TDEM representative(s) at least (30) days prior to the drill;

NBU has distributed the EOP to local Jurisdictions, including regional TDEM personnel and City of New Braunfels and Comal County Emergency Management Coordinators;

NBU has a Business Continuity Plan related to returning to normal operations after an emergency event or situation;

NBU's emergency management personnel who are designated to interact with local, state, and federal emergency management officials during emergency events have received the latest IS-100, IS-200, IS-700, and IS-800 National Incident Management System training."




